07/072 MATTERS ARISING AND OPPORTUNITY FOR PUBLIC QUESTIONS

Amanda Madden from Yorkshire Rural Community Council spoke about the affordable housing need in the Hambleton area. Many young people living in rural communities are finding it impossible to get onto the property ladder or rent in their local vicinity due to quickly rising prices. On exception sites the type and number of new homes are tightly restricted and must reflect local need. A district-wide survey asked residents questions in order to calculate how many local new homes would be needed up to 2009. This figure may need to be updated. Where more than one house is built, 40% of houses built must be affordable or a contributed sum must be paid to HDC to be used to build affordable houses in the district. The mortgage on an affordable house cannot be more than 3 ¹/₂ times a single person's gross income. For rented housing, the homes will be high design. For rental a house cannot be more than 25% of the household income. For shared ownership, where the owner owns a percentage of the house, it cannot be more than 30% of the gross household income. The housing association will always own 20% of a bought house. Housing associations will buy back houses at market value at the time the house was bought plus 3%. People who apply for the houses must have lived in the parish for 12 months. This time is being reviewed it was thought to be too short. At the end of October, people may look at a list of suggested sites and discuss affordable housing with Ms Madden. A secondary survey has been requested. Only 50% of houses requested will actually be built, so as not to spoil the character of the village. The village residents will be invited to choose the styles of the houses.

A survey will be sent to the parish council, who will be asked to comment on its suitability and make amendments if necessary. The survey will then be distributed to parishioners then returned to Ms Madden, who will analyse the results then pass them to the parish council.
